The office work chairs of model range "Mera NPR" comply with the dimensional requirements of NPR 1813, ed. 10.2009 and type B of DIN EN 1335, part 1.


Thus the requirements for ergonomic design of the EU-Visual Display Terminal Directive as laid out in DIN EN ISO 9241 part 5, ed. 08.1999 are met.

The requirements for durability and safety for the GS-Mark are proved in the test report of No 21170619-1.
